



IF YOUR CHILD IS CAUGHT IN THE POSSESSION OF TOBACCO OR NICOTINE PRODUCTS...

Persons under the age of 18 caught in possession, use, or purchase of tobacco or nicotine products are committing a noncriminal violation. Minors will be issued a citation by law enforcement, punishable by:

1st Violation: Pay \$30 fine, or complete 16 hours of community service, AND attend the approved anti-tobacco education class ***within 30 days.***

REGISTRATION FOR JUVENILE TOBACCO CITATION EDUCATION CLASS:

EPIC Behavioral Healthcare conducts the single Juvenile Tobacco Citation education class.

WHAT: This is the St. Johns County approved Tobacco Citation Education Class. Attending this class is a requirement for individuals who have received a tobacco citation.

WHERE: The Class will be held in person at EPIC's Central Campus, 1400 Old Dixie Hwy. Please check in at suite A.

WHEN: Every Wednesday of each month from 4:00pm – 5:30pm.

COST: \$30.00 fee for class (separate fee in addition to the citation fine) **BRING:** A copy of the citation

UPON RECEIPT OF A WRITTEN REQUEST FROM A RECIPIENT OF A CITATION, THE CLERK OF COURT IS AUTHORIZED TO GRANT ONE 30-DAY EXTENSION. UPON RECEIPT OF A WRITTEN REQUEST FROM THE CLASS PROVIDER, THE CLERK OF COURT IS AUTHORIZED TO GRANT ONE 60-DAY EXTENSION.
